

RMA Talent – Exclusive Casting Agency Agreement

RMA Talent is a specialist **casting agency** and screen-readiness company. Our role is to prepare actors for screen opportunities, connect them with suitable productions, and professionally facilitate casting and production engagements. Our services include showcasing the Actor across RMA's platforms, professional profile packaging where needed, casting submissions, audition support where appropriate, review and negotiation of contracts where required, coordination of communications with producers, oversight of engagement delivery, ensuring both parties understand and fulfill their contractual obligations, and professional support throughout the engagement. RMA does **not** provide talent management services.

RMA's objective is to increase the Actor's visibility, professionalism and access to meaningful opportunities while providing Producers with a reliable, efficient and well-supported casting experience.

Casting **opportunities include** feature films, short films, television, streaming productions, commercials, branded content, stage productions, voice-over work, and such other performance opportunities as may arise.

The Actor appoints RMA Talent as their **exclusive casting agency** for a period of **two (2) years**, automatically renewing for successive two-year terms unless either party gives at least **thirty (30) days' written notice** of termination.

For opportunities introduced or facilitated by RMA, RMA may coordinate auditions, negotiations, contracts, engagement communications and production support in accordance with the Producer's agreement. **RMA's casting fees shall be payable by the Producer.** Payments shall be made via RMA**. **

The Actor agrees not to bypass RMA in relation to any Producer, Production or opportunity first introduced by RMA. Any engagement under such introduction made during this Agreement, or within **twelve (12) months** following its termination, shall remain subject to this Agreement.

Where the Actor independently secures an acting engagement during the term of this Agreement, the Actor shall introduce RMA as the Actor's exclusive casting agency and request that all engagement communications be coordinated through RMA.

Where the Producer declines to engage RMA directly, or where the engagement is not otherwise covered by a Producer-paid casting agreement, the Actor shall pay RMA an **Engagement Coordination Fee** equal to **five percent (5%)** of the Actor's gross acting fee for ongoing services. In such case, RMA's services may include, but are not limited to, engagement coordination, contract review, communications, professional profile packaging, and professional support throughout the production where needed and as agreed with the production.

The Actor agrees to respond to casting requests, audition invitations and production communications from RMA within 24hrs and to promptly notify RMA if they become unavailable for any opportunity or engagement.

The Actor agrees to keep **confidential** all scripts, audition materials, callbacks, casting information, production documents, communications and other confidential materials received through RMA or any Producer, unless such information has already been made public or the Producer or RMA has given prior written consent for its disclosure.

The **Actor authorizes** RMA to collect, store, process and share the Actor's professional information and materials, including photographs, headshots, showreels, résumés, self-tapes, voice recordings, biographies and other casting-related materials, solely for the purposes of casting, promotion, submissions to Producers, production companies, directors, industry partners, production engagement, and the provision of RMA's services. RMA shall take reasonable steps to protect such information and shall not use or disclose it for unrelated purposes without the Actor's consent, except where required by law.
